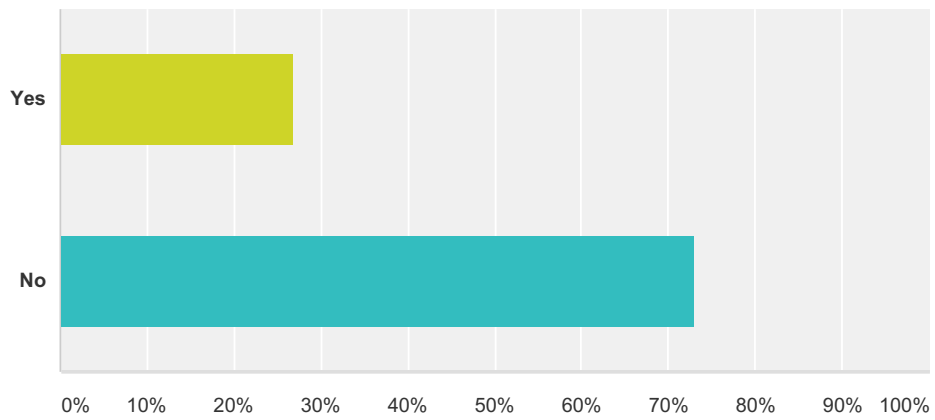


Q1 Did you attend the CALL/ACBD conference held in Winnipeg, May 2014?

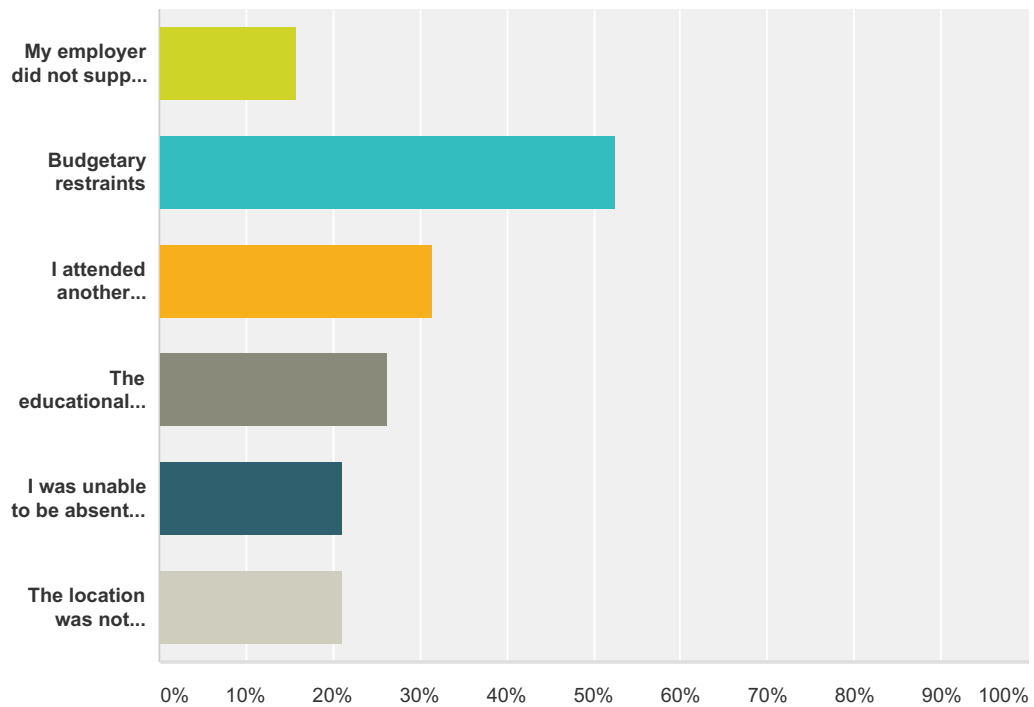

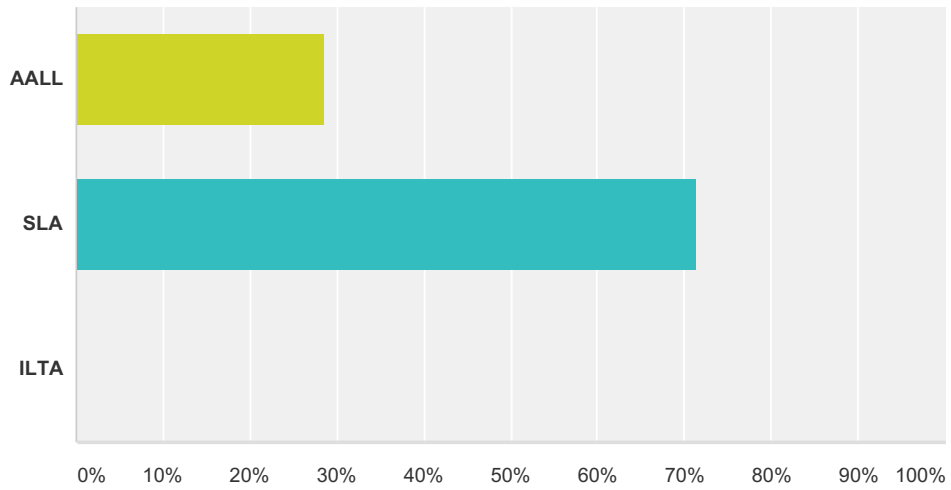

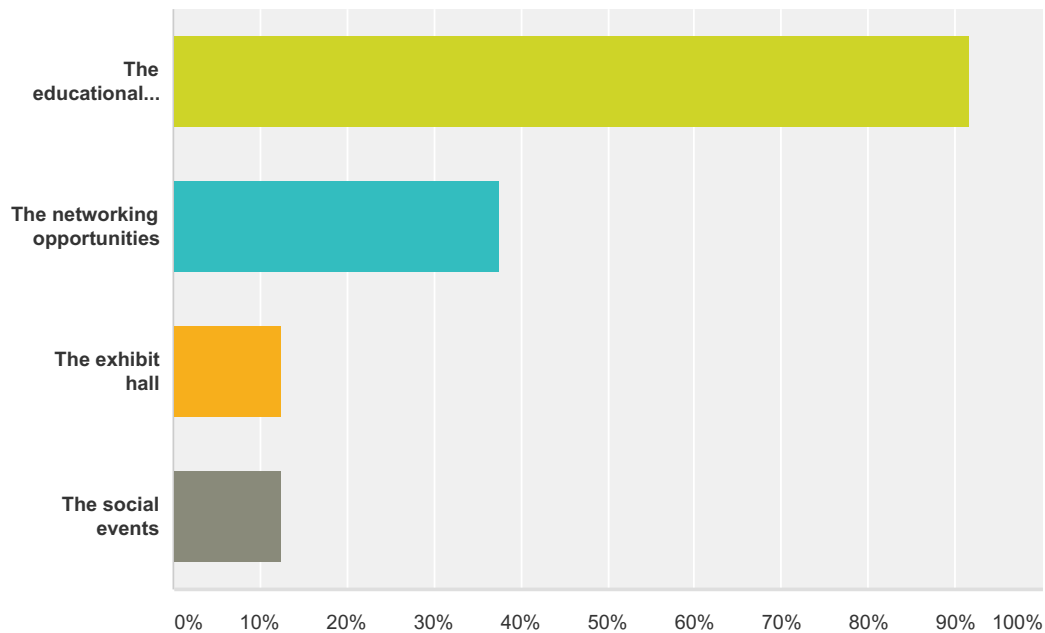

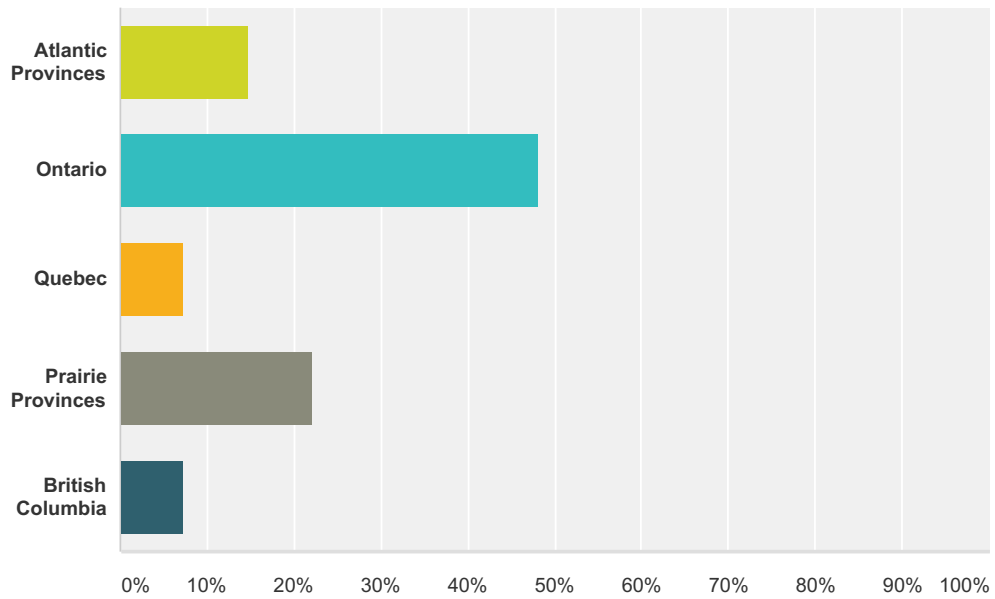
