## About:

Members of the Canadian Association of Law Libraries/Association canadienne des bibliothèques de droit who have been in good standing for a minimum of twelve months are invited to apply for funding from the CALL/ACBD Education Reserve Fund. The Education Reserve Fund will be used to award money to members to further their education in pursuits that do not fit the guidelines of already established scholarships. These could include such activities as library and/or law courses given outside Canada, study leaves and/or sabbaticals, or other educational activities that do not involve structured courses. These activities should be relevant to the applicant's career in law libraries and/or contribute to the development of law libraries or law librarianship. Attendance at the annual conferences of associations such as AALL, BIALL, IALL or CALL is not normally eligible.

Members of CALL/ACBD are encouraged to take advantage of this funding to further their professional education.

A written letter of support accompanying the application is encouraged but not mandatory. Recipients of grants from the Fund shall report back to the Scholarships and Awards Committee in writing, outlining the benefits they received.
